Greetings everyone! Happy New Year!

t's been a busy few months for me and I think I'm finally, as so many of you are as well, coming out of my post-election depression and ready to look ahead. I was deeply inspired and motivated to be able to attend the Women's March in Washington, DC on Saturday, January 21, 2017.

The Women's March was an amazing display of respect, kindness, and peaceful demonstration in reaction to the newly elected President of the United States and the Republican-controlled Congress. The purpose of the March was to send a clear message that we are not willing to set the clock back 40 years on the gains that we, as Americans, have made with respect to women's rights, minority rights, immigrant rights, LGBT rights, equal pay for equal work, healthcare for all, the funding of Planned Parenthood, and all issues that we as Americans care about. We need to remain attentive and well informed, question the "alternative facts", and continue to fight for the gains we have made during these past many years, and be active participants in the democratic process, if we are to continue as a free, democratic country. I am hopeful that we can, and will be able to accomplish this, with a lot of hard work!

In the weeks following the election, I was inundated with emails and phone calls from women all over the country asking how they can get involved, how to organize an NFDW chapter in their state or local area, and how to get started to run for office or help someone else run a successful campaign for elective office at the local, state, and national level. I was impressed by the number of phone calls and emails asking for help. For those I was able to connect with, I was able to direct them to their state federations and/or regional directors. I hope that has been helpful. We need their energy, their enthusiasm, and their activism!

One suggestion I was able to share was to organize a "Women in Blue" Day in their own states. There was a lot of interest in the "Women in Blue" committee at last year's annual NFDW Convention and I am hopeful (continued on page 2)

that this might be one way to begin to organize and focus on the down ballot races in 2017 and 2018. To many, I have suggested organizing "Women in Blue" events at the state level during the month of March because March is designated as "Women's History Month." Organizing and participating in "Women in Blue" activities in each of the states will certainly raise our profile and generate some enthusiasm among members and soon to be members! It should also be a wakeup call to our legislative leaders that we are not going away, not willing to sit back, and will continue to encourage women to run for elective office. The work has just begun!

Lastly, mark your calendars. This year's annual convention will be held in Atlanta, Georgia, June 8–11, 2017. The Georgia Federation is working very hard to make sure this convention is a great success. It promises to be a wonderful time for all, so you will not want to miss it! To all my Federation Sisters and supporters of democracy,

After all the hard work that you and so many others have put into the Presidential Election, the people have spoken and Donald Trump is now President-Elect of the United States of America. This has been an exhausting 18 months of an ugly campaign filled with bigotry, racism, crude language and insults for anyone who did not agree with him.

And yes, I am as devastated as all of you are, but this is the United States of America and it is time for all of us to stand together and give him a chance. Our democracy not only requires but demands the peaceful transfer of power. For 240 years we have respected this peaceful transfer of power and have proudly lived by this tradition and our values of decency, equal rights for all, dignity, and fairness to everyone.

As Hillary Clinton said in her very eloquent concession speech yesterday morning,

" this campaign was never about one person or even one election, it was about the country we love and about building an America that's hopeful, inclusive and big-hearted. Our constitutional democracy demands our participation, not just every four years but all the time."

Hillary Clinton has spent her entire life fighting for all of us, fighting for women and children, fighting for our families, and fighting for what she, and all of us believe in. She has been a champion for all of us and now it's our turn to move

forward with dignity and grace and "never stop believing that fighting for what's right is worth it." She has been our champion and handled this entire campaign with grace, composure, and dignity, in spite of the ugly rhetoric that has plagued all of us for these past many months. Now, it's our turn to thank her for her years of public service and do what we can to move this country forward.

It has only been 96 years since women gained the right to vote and no, we still have not shattered that glass ceiling, which so many of us had hoped we would. I truly believed that this was "our time" and that we would finally have elected the first woman president. I was so encouraged by the many women (and men) who stopped by the grave of Susan B. Anthony to leave their "I voted today" stickers. It made me proud to be an American and hopeful about the future of this great country.

What made me even more proud was the post that my own daughter, a classroom teacher, who as so many were, was worried about what she would tell her second grade students the next morning. On her Facebook page, and in her words: "I was pleasantly surprised by the level of posts, not about hate or anger, but about rising above, standing together, taking action, loving our neighbors of all races, sexualities, religions, genders, and colors, and remaining hopeful. The only way for things to get better is to take a stand. I was truly discouraged, but seeing all these positive posts restores my faith in humanity and in our country. If anything, I'm seeing more of how the future lies in our hands, especially the people of my generation and younger".

So for all of our daughters (and sons), a huge "Thank You" to Hillary Clinton for telling all of us that "our voices do need to be heard and we cannot give up the fight. And -- and to all the little girls, never doubt that you are valuable and powerful and deserving of every chance and opportunity in the world to pursue and achieve your own dreams."

So maybe the day will come "and sooner than we think right now" for someone to shatter that glass ceiling. Hopefully we will see it in our lifetimes and just maybe, if we all stand together, fight for what we believe in, and not give up, it might just happen in 2020 on the  $100^{th}$  anniversary of women gaining the right to vote. Let's get out there, stay strong, and keep fighting for what we believe in and what has always made our country so great.

- Nominee's resumes must be submitted with talents/skills highlighted along with endorsements from her state Federation Executive Board.
- · Submission of a black and white photo
- A signed statement from the candidate that says she will serve if elected to the office of
   "\_\_\_\_\_\_\_.". This statement is requested after the candidate has been contacted by the
   Nominating Committee for permission to put forth her name.
- No region shall have more than two (2) elected officers nor more than one (1) from the same state.

Dear State Presidents and Regional Director,

The NFDW Convention of 2017 will be on us before we know it. The Awards Committee wants you to start thinking about who would be deserving nominees from your home state. We are contacting you for nominees for consideration for: *Outstanding NFDW Member of the Year, Outstanding Elected Democratic Woman Holding Public Office and the NFDW Humanitarian Award.* 

These awards are presented annually during our NFDW Convention. The awards started with our NFDW founder, Rilla Moran Woods and others informally in 1986. In 1987, the awards were drafted, formalized with criteria and sent to NFDW members. States were encouraged to recognize Outstanding Democrats in these categories and forward the choices as a nominee for consideration to the Awards Committee Chair. The Awards Committee then presents the winners during the Awards Luncheon at the NFDW Convention.

It is the Committee's hope this year as it has been in the past, that you will encourage your members to participate in this process. Below are the guidelines for selection.

### **GUIDELINES AND CRITERIA FOR NOMINATIONS AND SELECTION**

- 1. In submitting the supporting information for a nominee, follow the criteria which is the basis for evaluating nominees for the Awards.
- 2. Present supportive material as numbered exhibits with the letter of nomination.
- 3. Nominations are to be submitted by State Federations, or where the entire state is not federated by a member club. The nominee need not be a resident of the state submitting the nomination.
- 4. The nominee must be present at the National Convention to receive the award, unless some unforseen event occurs to prevent attendence.
- 5. Organizations are requested to limit nominations to one per category.

- 1. Significant contribution to the cause of human and/or civil rights.
- 2. Demonstrated support of the NFDW.
- 3. Nominee possesses leadership qualities.
- 4. Nominee's success in achieving human and /or civil rights. (The nominee may be male or female but must meet the criteria.)

# TIME IS SHORT for CLUBS to SUBMIT RESOLUTIONS DUE BY MAY 1, 2017

Resolutions must be submitted to the Chair of the Resolutions Committee one (l) month prior to the Annual Meeting. The Resolutions Committee shall present all resolutions to the Annual Meeting together with Committee recommendations. Resolutions signed by at least (10) delegates representing at least (5) states may be received from the floor.



Resolutions should be short and to the point, addressing only one concern, should contain no more than three statements beginning with "Whereas," and should make only one recommendation in the statement beginning with "Resolved."

The resolve should require action that can be accomplished. There should be only one issue in a resolution. If more than one is needed, a separate resolution should address that issue.

The president and vice president seats on the Executive Board were contested races between four very strong, qualified women. In a show of moving solidarity, the two candidates for






