TIME IS SHORT for CLUBS to SUBMIT.



RESOLUTIONS DUE BY May 1, 2018

Resolutions must be submitted to the Chair of the Resolutions Committee one (1) month prior to the Annual Meeting. The Resolutions Committee shall present all resolutions to the Annual Meeting together with Committee recommendations. Resolutions signed by at least (10) delegates representing at least (5) states may be received from the floor.

Resolutions should be <u>short and to the point</u>, addressing only one concern, should contain <u>no</u> <u>more than three statements beginning with "Whereas,"</u> and should make only <u>one recommendation</u> in the statement beginning with "Resolved."

The resolve should require action that can be accomplished. There should be only one issue in a resolution. If more than one is needed, a separate resolution should address that issue.

December we had our *Holiday Gathering/General Meeting* in Cheshire at the home of First Vice-President Judy Villa. It was attended by members from Waterbury, Groton, Stonington, Cheshire, Hartford, Norwich, and East Hartford (I may have missed a town or two!) Food and company was wonderful, we collected money for Puerto Rican relief, had lively discussion on current events, and managed to get some planning accom-

January was dedicated to planning events, but we had a big event, too! The *Women's March* on Jan. 20. Members attended marches in Hartford, New York, and locally. There were 10,000-12,000 women, men, teens, and children in Hartford alone. We have a new banner, here proudly displayed by Dave Coleman and Kathy Harrington Coleman, and we even got photo bombed!





We had our February General meeting at the Manor Inn in Milldale. Rep. Liz Linehan, $103^{\rm rd}$ Connecticut District, told of being sexually assaulted in the workplace, and how her then-chosen career was derailed when she reported it, while virtually nothing happened to the man involved. She next discussed legislation she is proposing to safeguard workers who go through similar on-the-job experiences, ensuring they are treated fairly and not suffer job retaliation. To say it was an interesting, though at times painful to listen to, experience, is an understatement.

On March 23rd, we are having a very special event, the *Women of Distinction Dinner* in East Hartford. We want to recognize the women who do a great amount for their clubs and the Democratic Party, but rarely get recognized for the great contributions they make. We're quite excited about it, and plan to honor a woman from each of our clubs, each will receive an award, and be included in the National Federation of Democratic Convention booklet.

March is a busy month! On March 7th, women from Connecticut plan on being in Washington D.C. for *Women In Blue Day*, and visit their elected officials at the Capitol. Connecticut will be having its own *Women In Blue Day* on Wednesday, March 28. We will converge on our Hartford Capitol, all in blue, to meet with our representatives and senators, and already have a room reserved in the Capitol for the day. Should be quite an event, as we certainly have a lot to say. Events are also being planned for April in East Hartford and for May in Colchester. And we are all looking forward to, and will be working for, a mighty **Blue Wave** in November!

District of Columbia

Washington, DC.- On September 20, 2017, the DC Federation of Democratic Women hosted a reception to launch The Congresswoman Eleanor Holmes Norton Legacy Scholarship and Luncheon. The 1st Annual EHN Legacy Luncheon will be held in June 2018. In preparation for this highly anticipated event, DCFDW hosted a fundraising reception, hosted and sponsored by Attorney A. Scott Bolden, former chair of the DC Democratic Party and Managing Partner at the Reed Smith Law firm in downtown Washington, D.C. The Norton



Legacy Scholarship will be presented to deserving students at the 1st Annual EHN Legacy Luncheon. The goal is to honor our "Warrior on the Hill" and help future "Warriors" with their educational pursuits. The scholarship in the name of Eleanor Holmes Norton will be in the fields of law, public policy and political science. The scholarship and the 2018 Eleanor Holmes Norton Legacy Luncheon are designed to have Black women in the political arena achieve political power.

D.C. Mayor Muriel Bowser, D.C. Council Chairman Phil Mendelson (D) and D.C. Council members Anita Bonds (D-At Large) and Kenyan McDuffie (D-Ward 5) were among more than 75 guests that attended on Sept. 20. Other notables included former D.C. Mayor Sharon Pratt (D), former U.S. Labor Secretary Alexis Herman, former D.C. Council member Sandy Allen, Julianna Malveaux, former president of Bennett College for Women and Prince George's County Executive Rushern Baker III.

Norton, a District native who graduated from Paul Laurence Dunbar High School in 1955, has served as the city's sole representative to the Congress since 1991. Before her political career, she gained a solid reputation as a scholar and activist on African American and female rights, with her service as the head of the New York City Human Rights Commission by Mayor John Lindsay in 1970 and in 1977 President Carter appointed her as the head of the Equal Employment Opportunity Commission.

Norton was a professor at the Georgetown University Law Center from 1981 until she became a member of Congress. While in Congress, she has distinguished herself as a fighter for the District and in the areas of constitutional and civil rights law.

Norton said, "To name a scholarship in my honor has a lot of personal meaning for me." She said that as a Black girl growing up in the District in the 1940s and 50s, there were two primary barriers to full citizenship. "Washington, D.C. was a segregated city and it was a city with no democracy," she said. "An un-elected Congress ran this city and they still try to do that but I stop them."

Several other Senators joined us for our picture on the Capitol Steps.

Our Spring Luncheon is planned for April 14 from 11:30 to 1:30 at Tam's Backstage in Cumming, GA. The theme of the event will be "Year of the Women – 2018". Our speakers will be women in the Atlanta area who recently won elections in 2017 and began their terms in 2018. We will also have many of the state and local candidates at the luncheon. In addition, we will present our yearly awards to outstanding members and chapters of GFDW in Georgia.

We also had several special elections in Georgia in December of 2017 and January 2018. Our South Fulton chapter held multiple candidate forums and "Meet and Greets". Seven Councilmembers and a Mayor were elected in the new city of South Fulton. Also, Henry County Democratic Women played an instrumental role in the phone banking and canvassing for house seat 111 and senate seat 17 for the special election January 9th.

Florida



The Democratic Women's Club of Florida held their annual Tally Days February 4-7 where they heard speakers on large number of current issues relating to impending legislation being debated in the Florida Legislature. Approximately 175 members were in attendance. While there, many appeared at a Florida Senate committee hearing for a bill that would prevent Fracking in Florida. The #Blue Wave prevailed and the bill to prevent Fracking in Florida passed Committee to go to the Senate Floor. The meeting included a full day of intensive lecture on bills about issues as varied as the Right of choice, fracking, ending child marriage, ending unions, educational funding, the tax structure, decriminalization of Marijuana, voter suppression, and guns on campuses. Later that evening the group attended a fundraiser reception for their Political Committee with Democratic candidates from all across their state. The next day in the Capitol Rotunda they held a press conference for Ratifi-

Missouri

Missouri FDW President Cindy Jenks is sharing this important history ~



On June 1, 1843, Isabella Baumfree changed her name to Sojourner Truth, devoting her life to Methodism and the abolition of slavery. In 1844, Truth joined the Northampton Association of Education and Industry in Northampton, Massachusetts. Founded by abolitionists, the organization supported a broad reform agenda including women's rights and pacifism. Truth never learned to read or write; however, in 1850, she dictated what would become her autobiography — The Narrative of Sojourner Truth — to Olive Gilbert, who assisted in its publication. Truth survived on sales of the book,

which also brought her national recognition.

Sojourner Truth delivered her "Ain't I a Woman?" speech in 1851 at the Women's Rights Convention in Akron, Ohio. Her short, simple speech was a powerful rebuke to many anti-feminist arguments of the day. It became, and continues to serve, as a classic expression of women's rights. Truth became, and still is today, a symbol of strong women.

In 1851, Truth attended the Women's Rights Convention in Ohio. According to Frances Gage, the president of the Convention, on the second day several male ministers showed up and argued that women should not have the same rights as men. The ministers' reasoning: women were weak, men were intellectually superior to women, Jesus was a man, and our first mother sinned.

Sojourner Truth rose and (amidst protests from some of the women who feared she would talk about abolition) delivered her short, masterful speech-invoking tenets of Christianity and using her strong, imposing presence to debunk the ministers arguments. Pointing to her well-muscled arms and referring to the hard work she performed as a slave, she allegedly declared, "And ain't I a woman?" By all accounts, as Truth spoke, the crowd in the church rose and wildly applauded.

"Ain't I a Woman?" as recounted by Frances Gage, in 1863:

"Well, children, where there is so much racket there must be something out of kilter. I think that 'twixt the negroes of the South and the women at the North, all talking about rights, the white men will be in a fix pretty soon. But what's all this here talking about?

That man over there says that women need to be helped into carriages, and lifted over ditches, and to have the best place everywhere. Nobody ever helps me into carriages, or over mud-puddles, or gives me any best place! And ain't I a woman? Look at me! Look at my arm! I have ploughed and planted, and gathered into barns, and no man could head me! And ain't I a woman? I could work as much and eat as much as a man-when I could get it-and bear the lash as well! And ain't I a woman? I have borne thirteen children, and seen most all sold off to slavery, and when I cried out with my mother's grief, none but Jesus heard me! And ain't I a woman?

Then they talk about this thing in the head; what's this they call it? [member of audience whispers, "intellect"] That's it, honey. What's that got to do with women's rights or negroes' rights? If my cup won't hold but a pint, and yours holds a quart, wouldn't you be mean not to let me have my little half measure full?

Then that little man in black there, he says women can't have as much rights as men, 'cause Christ wasn't a woman! Where did your Christ come from? Where did your Christ come from? From God and a woman! Man had nothing to do with Him.

If the first woman God ever made was strong enough to turn the world upside down all alone, these women together ought to be able to turn it back, and get it right side up again! And now they is asking to do it, the men better let them.

Obliged to you for hearing me, and now old Sojourner ain't got nothing more to say."
