It's 2012.

It is hard to believe that it is 2012 and it has been almost four years since the American populace had the wisdom to elect President Barack Obama as the head of our great nation and yes, the world is a different and much better place thanks to him and the Democratic leadership.

Often when we hear critics and listen to the rhetoric of the Republican challengers we forget where our country was when he assumed the presidency.

The economy has improved – jobs have been created, unemployment is down, and the U.S. auto industry is showing a profit for the first time in years in spite of the enormity of the financial crisis and global economic uncertainty. His administration made it possible for more people to attend institutions of higher learning by strengthening the Pell Grant program and investing in community colleges and Historically Black colleges and assisted many young people and their families, by capping student loan re-payments at 10 per cent of discretionary income. He has sought to curb and stop domestic violence and sexual assault and reauthorized the Child Abuse Prevention Act. In appointing two women to the Supreme Court he has added needed diversity and balance that will leave a lasting legacy for America.

### Monica Honis – Councilwoman in Teaneck, Bergen County, NJ

onica is a graduate of Paramus Catholic and Lincoln University where she earned a Bachelor's degree in Political Science and Spanish. She did her graduate work at New Jersey City University in the area of multicultural relations and education. She is currently a middle school English as a second language teacher specializing in science. In addition, she created the curriculum for the elementary foreign language program at East Orange Community School and has written curriculum for several boards of education.

Ms. Honis made history in 2004 by becoming the first woman of color ever elected to the Teaneck Township Municipal Council and was rewarded with a second term in May 2008.



She has worked on numerous quality of life issues including rent control, traffic safety and environmental concerns. Recently, she worked with a partnership to obtain and preserve an ancient burial ground that is the resting place of Native Americans, African Americans and the first Dutch settlers.

Monica serves as liaison to the Municipal Alliance Against Substance Abuse, the Forum, the Hackensack River Greenway and the Historic Burial Ground. She is a member of the Holy Name Hospital Community Relations Board and the St. Anastasia's R.C. Church Parish Council, is actively involved in Alpha Kappa Alpha Sorority, the Bergen County Black Caucus, the Latino American Democratic Association, the National Coalition of 100 Black Women, the Women's Rights Information Center, serves as a Trustee for Vincent K. Tibbs School, is Recording Secretary for the NJ Federation of Democratic Women, a past Trustee for Court Appointed Special Advocates, and serves her community on many committees. # Michigan Young Women's Leadership Training

ichigan Democratic Women Caucus (Michigan Federation) had their Annual Young Women's Leadership Training which was a great success. We had over 150 young women participating with great speakers and a lively crowd. The event was chaired by Virgie M Rollins, Chair Emeritus of the Michigan Women, Past President of the NFDW and Chair of DNC Black Caucus.

To kick off the training Virgie gave a rousing welcome and history talk. She spoke about how young women are the future and must step up and get involved. Michigan Chair Trina Ellis (NFDW 3rd Vice President) welcomed everyone and gave the agenda for the upcoming events. Trina was followed by a panel of great speakers who told their stories on how they worked their way into leadership, and guidance on how women can make the largest impact in their communities through, policy, politics, organizing and running for elected office.

Kelly Green our past NFDW Intern told her story about how her involvement with the NFDW lead her to become the intern for the DNC; and how she ended up serving as chief of staff for the Secretary of State of New Jersey, a field operative for Clinton and Obama and running some of the most important elements of their campaigns. Kelly encouraged young women to work hard, get involved and not to give up.

The Vice President of International Union of the UAW Cindy Estrada told her story of a young Hispanic women and her rise to become the only female and first Latina to serve as Vice President of the United Auto Workers Union. She grew up in Detroit, Michigan helping her family with their pub that was located next to a very large UAW local, and how the lives of the working people set her on a path to help others, which lead her to California to work for Dolores Huerta who co-founded the United Farm Workers Union with Cesar Chavez. She came back to Michigan and worked hard to make a difference as an organizer for the UAW, and how she took the chance and ran to become the Vice President of the UAW. Following her boss, Georgi-Ann Bargamian who heads the UAW women's department, guided us through the logistics of how to lead in a man's world, and how to lift up all women. Rep. Lesia Liss one of the youngest women in the Michigan House of Representatives, told everyone how important it was for women to run for office. She had been a nurse and had not been politically involved before her run, but how her voice had made a difference in the legislature. She said it was important for us to encourage and ask women to get out and run for office. Dr. Laura Moseley, JD was the moderator and gave an overview of women in the work force, in campaigns and how important it is to reelect President Obama. She also summed up the state of the economy and the dangers of the obstructionist Republicans.

Tami Arreguin past NFDW Regional Director and staff for Detroit City Council Speaker Pro-Tem Gary Brown was the organizer of the event and concluded with how important it is for young women to volunteer their time for a political office or campaigns and how it can lead to a long and successful career in politics. She then fielded questions for the panel and thanked everyone for attending.

## **Upward Trend of Female Candidates for Congress**

This is exurbs from an article by Susan Davis in USA Today newspaper January 30, 2012 page 4A. I thought there was some important information to share along with a final comment.

This year, a notable number of candidates are running in potentially competitive races in both the House of Representatives and Senate that could send a wave of female lawmakers to Washington in November. If so, it would reverse the 2010 election trend that saw the first dip in female representation in the House since 1978 and only sent one woman, New Hampshire Republican Kelly Ayotte, to the Senate.

In the 2012 Senate lineup, there are 10 female candidates, - 4 Republicans and 6 Democrats – seeking office. Of the six states with female Democratic candidates – Connecticut, Hawaii, Massachusetts, Nevada, North Dakota and Wisconsin – none has ever elected a woman to the Senate. Republican women are also running in Connecticut, Hawaii, Missouri and New Mexico.

The Democratic congressional campaign operation is fielding candidates in 76 House races they hope to make competitive, and about half of those districts have female candidates. Republicans agree, but have recruited only 7 candidates for competitive races.

"Many of us view gender parity as a goal for Congress," said Rep. Jared Polis, D-Colo., who has helped recruit candidates this year.

# Democratic Women of Florida, Inc., works to make 2012 the "Year of the Democratic Woman" in Florida

he Democratic Women's Club of Florida, Inc., has hit the ground running in preparation for the critical 2012 redistricting election. In preparation for the early opening day of the Florida legislative session — convening two months earlier than usual due to redistricting, the Democratic Women's Club of Florida, Inc., released its 2012 legislative agenda immediately after the New Year's holiday. With the Democratic Women's Club of Florida, Inc., announced legislative agenda, the organization declared the group's main priority for the year — fairness for all Floridians.

"In 2011, Floridians were under attack on all fronts — our state's citizens were fair game for the Florida Legislature," said DWCF, Inc. President Janet Goen. Goen said, "In 2012, the Democratic Women's Club of Florida, Inc. calls on the elected officials of Florida to keep fairness paramount in their actions while in Tallahassee."

DWCF, Inc. Legislative Director Dr. Maureen McKenna stated, "Republican legislators and Florida's job-killing governor "Pink Slip Rick" have attacked citizens' rights on every level. Last year, Florida citizens stood against an assault on voting rights, reproductive rights, and workers' rights." McKenna further asserted, "The war on women is slated to continue in 2012. Legislators seek to limit women's access to healthcare, curtail our access to the polls, and further inhibit our ability to be productive workers who contribute to Florida's economic growth."

The Democratic Women's Club of Florida, Inc. calls for legislators, during the 2012 Legislative Session, to honor the will of Florida's voters as expressed in the "Fair Districts" Amendments (Amendments 5 and 6) of 2010; to stop the war on women and to cease the continued attacks on women's access to life-saving reproductive health care; and to support women workers as an important part of revitalizing Florida's stalled economic engine — including passage of the Equal Rights Amendment.

Members of the Democratic Women's Club of Florida, Inc. will bring their legislative agenda to Tallahassee in person on February 6 and 7, 2012. Women from throughout the state will bring their call for fairness to the Capitol as part of the DWCF, Inc.'s "Tally Days" — an annual event devoted to awareness, education, and advocacy.

One much anticipated workshop for the annual Tally Days will focus on key legislative issues in Florida during the critical 2012 election year. So much for their "No tax pledge!"

While at the State Capitol, many of our attendees had the opportunity for visit with their legislators. GFDW then took the lead in a Capitol press conference to promote Georgia's voluntary state income tax check-off to support cancer research in Georgia. As a member of the House of Representatives, our very own president, Gail Buckner, was author of the original legislative that started the fund in the year 2000. To date, over \$3 million has been donated to cancer research. GFDW was pleased to spotlight this extraordinary effort. We believe that a cure for cancer will be found in our lifetime.

GFDW's newest project is to partner with the Georgia Department of Tourism to help establish a historical marker that recognizes First Lady Michelle Obama's Great-great-great grandmother, Melvinia Shields, lived in our Rex community. This male child was named Dolphus Shields, and he is recognized as the First Lady's Great-great grandfather. The scholarship will be named to honor both Melvinia Shields and First Lady Michelle Obama. 
