### Overview

The Democratic National Committee met in Philadelphia, on February 2-4. 2023, for its Annual winter meeting. With over 1,000 DNC members, state party leaders, donors, press, and guests in attendance, the 3-day meeting was headlined Thursday night by a visit from President Biden, Vice President Harris, and Speaker Emerita Nancy Pelosi. The Regional Caucuses and the Constituency Caucuses and Councils held their meetings on Friday to discuss ways to energize within their communities as we gear up for the Presidential election in 2024.

At the Saturday General Session, DNC delegates approved the recommendations of the Rules and Bylaws Committee to reshuffle the Presidential Primary Calendar to allow South Carolina to hold the first primary on February 3, followed by New Hampshire, and Nevada to be more in line with our democratic demographics and expands the number of voices for our diverse communities.

### DNC Black Caucus Breakfast to Celebrate Black History Month

Another great event at the DNC Winter meeting was the Black History Month breakfast sponsored by the DNC Black Caucus. With all seats filled and others standing, a fabulous program was presented that highlighted so many leaders and their accomplishments. As always, Congressman James Clyburn rocked the room with his statesman approach to everything, including when he pinged South Carolina Party Chair Trav Robertson who had walked over to the door, "Trav, are you walking out on my speech? He even calls me Daddy sometimes." The National Federation of Democratic Women were well represented with DNC Black Caucus Chair Virgie Rollins leading the program, Past President Joanne Sullivan, and President Gail Buckner in attendance.

### DNC WINTER MEETING RECAP

### Early Primary States

As you are well aware, President Biden called on the DNC last year to alter the 2024 presidential primary calendar to ensure the early states better reflected the diversity of America and the inclusiveness of our great party. The proposed "early states" calendar would move South Carolina first, followed by Nevada and New Hampshire, then Georgia, followed by Michigan. For any state to move its primary up before March 5th, a waiver is required by the DNC. In December, the DNC Rules and Bylaws Committee formally approved President Biden's plan and recommended the DNC grant waivers to each of these five states to allow them to set their primaries ahead of the regular window. This past Saturday, the DNC formally ratified the recommendations of the Rules and Bylaws Committee, providing waivers to each of these five states, allowing them to move their primary elections up in the cycle if they meet the conditional requirements set by the DNC.

Of these early states, South Carolina, Nevada, and Michigan has already met the conditions required by the waiver. Saturday's vote by the DNC extended the deadline to June 3, 2023, for Georgia and New Hampshire to meet the required conditions of the waiver. Unlike New Hampshire, for Georgia to move our Presidential Preference Primary up does not require a state law change. Our presidential primary dates are set solely by our Secretary of State. Secretary Raffensperger has said publicly that he supports the idea of moving Georgia's primary earlier, citing Georgia's "good cross-section of engaged voters from both parties," but does not want to hold two separate primaries nor set a Georgia election calendar that would jeopardize the awarding of delegates on the Republican side (which the RNC rules-similar to the DNC rules in this regard- demand as a punishment for any state that moves its state primary up in the process without prior ratification by the RNC). Rest assured that we are continuing to engage on this topic with stakeholders across the state to make this happen, so stay tuned for developments.

### **DNC Rural Council**

The Rural Caucus is composed of DNC members from throughout our country. Constant commentary leaned in the same direction: Democrats must meet rural voters where they are. We must talk to them about keeping their schools open, keeping their pharmacies and hospitals open, as well as keeping grocery stores open. They are concerned about water availability, clean water, and so many more critical issues.

### **DNC AAPI Caucus**

The AAPI Caucus meeting was a celebration of the great accomplishments of this constituency group. APPI Americans are the fastest-growing racial/ethnic group in our country with 15 million citizens nationwide. They were dedicated to helping Democrats win the midterm (which we know firsthand in Georgia). A talented field organizer was on the ground in Savannah during Senator Warnock's run-off election.

Entertainment executive and songwriter Tim Huang came down from New York to speak about the importance of APPI citizens in the arts. This caucus is doing very exciting work!

The position of Treasurer is now open. We are asking any candidate from the following federations in the Eastern Region who meets the requirements to apply: New Jersey, Connecticut, Pennsylvania, Puerto Rico, District of Columbia and Women's National Democratic Club.

The duties of the Treasurer per Bylaws are: Shall cosign all checks with the President or other authorized persons. No less than thirty (30) days prior to the close of the fiscal year, the Treasurer shall send bills for the next fiscal year's dues; she shall collect the same and notify the President and the Executive Board of states in arrears. She shall pay all bills, which have been approved by the President or the Executive Board. She shall submit to the Executive Board a quarterly statement of all receipts and disbursements. The Treasurer shall furnish a surety bond, which shall meet the requirements specified by the Executive Board. The bond premium shall be paid by the NFDW. The Treasurer's books shall be audited at the end of each fiscal year by an Audit Committee consisting of three members, each from a different state, to be appointed by the President with the approval of the Executive Board.

The requirements per Bylaws are: a nominee must have been a Federation member in the state in which she resides for no less than two (2) years and have participated in at least three (3) previous conventions in addition to the one where the election of officers is held.

You need to submit the documentation as listed on page 14 in the NFDW Policy and Procedures Handbook, which can be found on our website.

June 1, 2023

### CALL FOR RESOLUTIONS

#### **Timeline for Resolutions Submission:**

- Any time between April 1st through May 10th resolutions must be submitted to the Chairs of the Resolutions Committee by to comply with lead time before the Annual Meeting in June.
- All submissions will be forwarded to the Resolutions Committee for review and editing suggestions;
- Substantive edits will be sent back to the original submitter;
- May 10th deadline for submission of all revisions or amendments.
- Final drafts will be shared with all club presidents.
- The Resolutions Committee shall present all resolutions for a vote of approval at the Annual Meeting in June 2023.
- Resolutions from the floor will be accepted only for an emergent issue and must be signed by at least ten (10) delegates representing at least five (5) states.

### **Required Resolutions Format:**

- Resolutions should be short and to the point, addressing only one concern, should contain no more than three statements beginning with "Whereas," and should make only one recommendation as an action statement beginning with "Resolved."
- The resolve should require action that is of national importance that can be accomplished. There should be only one issue in a resolution. If more than one is needed, a separate resolution should address that issue.
- These requirements are consistent with the DNC resolutions format and platform as approved NFDW resolutions are submitted to the DNC for consideration.

The total number of resolutions that are statements of principles is limited to seven (7) each year; commemorative or honorary resolutions may also be accepted. Each year, NFDW's adopted resolutions are filed with the Library of Congress, forwarded to the DNC, published in the Federation newsletter, and posted to the NFDW website.

### ARKANSAS UPDATES

### Arkansas Under Attack

Arkansans are under attack. With our new governor, Sarah Sanders-yes, the former Press Secretary for the Trump administration-and a Republican supermajority in the state house and senate, laws are being passed with no consideration or discussion from constituents at a record pace.

Our state legislature came together at the beginning of January. In just this short amount of time, legislators passed some of the most egregious legislation in the country.

- Banning trans people from using the bathroom they identify with, and it's now considered a sex crime if they are in a public bathroom and a minor is present.
- The "LEARNS Act" overhauls public schools, making way for vouchers for private and home-schooling that will not be held to the same standards as public schools. Inside that act, they have disguised a one-time teacher pay raise/minimum to hide the fact that long-tenured teachers may never get a raise again.
- They've passed a bill to construct a "monument to the unborn, aborted children of Arkansas" on the Capitol grounds.
- A bill requiring "adult" website operators to verify user's age passed the state house.
- Banning gender-affirming care for trans youth created a dangerous, first-of-its-kind provision that—unlike existing medical malpractice laws—would allow legal action against physicians who violate standards of care.
- A frightening and dangerous bill allows someone who does not live in your community or use your library to bring a claim against a book for almost any reason.
- Right now, there is a bill sailing through that will eliminate Affirmative Action in Arkansas, threatening the funding and the operation of all HBCUs, Black History Museums, and even businesses owned by women and disabled veterans.
- And very recently, the Governor introduced a bill to build more prisons and keep people incarcerated longer. Arkansas already has one of the highest incarceration rates in the world.

We have also had a few wins at the county and state levels. As an organization, we are proud of our small but mighty Democratic caucus that shows up every day and never quits fighting.

A pro-life county resolution has been voted down!

- JP Esther Dixon (D)—one of three Dems and only two women on the Garland Co Quorum Court of organized preliminary discussions with concerned citizens, invited many to speak, and many more to attend. Those in opposition to the Resolution packed the courtroom! About a dozen people spoke, and only three spoke in favor of the The Committee voted, and the resolution. Resolution was defeated at Committee level 4-3!!! This means it was not to be forwarded to the full court for further review (at least for now!). This is a common "resolution" making its way county to county in Arkansas, looking to proclaim a county pro-life even when there are unhoused people, hungry people, and exponentially growing rates of targeted incarceration and deportation. That's not very "pro-life" in our eyes.
- Representative Ashley Hudson (D) sponsored Act 128, which requires schools to "excuse absences due to conditions related to pregnancy or parenting," including for labor, delivery, recovery, prenatal, and postnatal appointments. This has successfully passed. Unfortunately, this is the type of reactive measures we are having to take to mitigate our wildly strict bans on reproductive healthcare.
- Representative Denise Garner introduced HB1684, which would give an exception for abortion to save the life of a mother. The bill will be assigned to a committee Monday. This is another attempt in this session to help support reproductive healthcare for Arkansans under the current strict bans on abortion.
- Governor Sanders signed House Bill 1315 into law bringing Seizure Safe Schools legislation to 20 states nationwide. Representative Denise Ennett (D) and Senator Linda Chesterfield (D) sponsored this legislation!

### **WOMEN IN BLUE**



On March 15, 2023, the DC Federation of Democratic Women (DCFDW) organized a successful virtual Women in Blue Advocacy Day, engaging the Mayor and the DC City Council in essential conversations surrounding pressing local issues. The Women in Blue Committee, Chaired by Gaby L. Fraser, facilitated rich discussions with Mayor Muriel Bowser and 11 City Council Members. Representatives were sent on behalf of the two Council members who were unable to attend.

The DCFDW provided the Mayor and City Council with a booklet of 17 position papers, addressing a range of topics including election fairness, reducing the fundraising burden on candidates, nurse-to-patient staffing ratios, employment opportunities for black and brown youth, and addressing the increase in gun violence within the District of Columbia. The members of the DCFDW also took the opportunity to discuss strategies for improving relations between cyclists and motor vehicle operators and promoting environmental equity within the city.

The Women in Blue Local Advocacy Day proved to be a well-organized and insightful event, allowing the women of the DCFDW to make their voices heard on critical issues affecting all 8 Wards in the city.

DC Mayor, Muriel Bowser, joined the DCFDW virtually for our annual Women in Blue.

## DC LIBRARY NAMED FOR NAMED FOR LILLIAN J. HUFF

Lillian J. Huff, founding President of the DC Federation of Democratic Women (DCFDW), was honored on March 18, 2023, at an unveiling ceremony and renaming of the Lamond-Riggs building, now the Lillian J. Huff Library. With the renaming, the Lillian J. Huff Library became only the third library in the District of Columbia to be named in honor of a Black woman. DCFDW members Linda Jefferson, Hazel Thomas, Gwendolyn Johnson, Lyndia Grant, and Vivian Wilds served on the Lillian G. Huff Renaming Committee that advocated for over two years to garner support for the renaming of the new library.

Rilla Moran Woods, NFDW's first president, asked Mrs. Huff to establish a state affiliate in the District of Columbia; the latter worked with C. Dolores Tucker and others to create the DC Federation. Mrs. Huff was one of the first women to co-chair the DC Democratic State (previously the Central) Committee; she also chaired the first Home Rule Constitution Convention, essential to gaining statehood. Mrs. Huff was an activist and community organizer who lobbied Congress to secure funding to build the original Lamond-Riggs Library which opened in 1983.

### FLORIDA UPDATES

The Florida Federation has had a busy first quarter in 2023. Our state legislature began committee weeks in January, with the Legislative Session beginning on March 6th. We continue to have members in Tallahassee every week to speak out against the DeSantis Agenda as it plays out in our Capitol. ### Growth! Growth! Growth!

The NYSFDW continued on its path of growth and development in the new year with the addition of three new county chapters, two of which are highlighted here. We also resumed our highly successful "Lunch and Learn" series, which has served to educate and engage voters throughout the state.

His race was a critical win for House Democrats in the midterm election.

Our two-day convention was preceded by our inaugural Women In Blue Advocacy Day at the Oklahoma State Capitol on Thursday, March 23, 2023, where we were greeted warmly and educated by several of our phenomenal Democratic legislators, including Representatives Trish Ranson (Stillwater), Monroe Nichols (Tulsa), Melissa Provenzano (Tulsa), and Oklahoma City State Senators Carri Hicks, Rev. George Young, Sr., and Democratic Leader Kay Floyd.
