President's Message

As we are preparing for NFDW's national convention, this is a great time to reflect on the many transformational changes that President Joe Biden's administration has delivered for our country. While the Biden agenda is improving Americans' lives, he has risen in stature for his leadership of NATO and the world in fighting the hideous invasion of Ukraine that

signals a growing threat to democracy across the continents.

In the midst of a global pandemic, the American Relief Act kept millions of Americans from being homeless and hungry. The Child Tax Credit moved millions of children out of poverty. The historic Bipartisan Infrastructure Bill is not only repairing the hundreds of bridges that are in need of structural improvements, but also thousands of jobs are being created in the process. In fact, the Biden Administration has set an all-time jobs growth record by adding

6.6 million jobs throughout our nation. This is record-setting for a president in the first year in office.

According to the White House, unemployment has fallen from 6.2% to 3.8%, and unemployment is at the lowest level since 1968. When President Biden took office, 18 million individuals were receiving unemployment checks. "Today, those receiving unemployment benefits have dropped to 2 million. Let's learn from this phenomenal woman and emulate her.

The Democratic National Committee's Winter Meeting took place March 10 - 11, 2022 in Washington, D.C. for its first in-person meeting in two years. The meeting was highlighted by visits from President Biden and Vice President Harris with an audience of over 1,000 national committee members, state party leaders, donors, press, and guests.

Black Caucus Chair, Virgie Rollins was reelected as Chair of the Black Caucus in a rousing, well attended caucus meeting with more than 100 participants. Congratulations, Virgie on a job well done! Senior advisor to President Biden & former Congressman Cedric Richmond gave remarks as well as Erin Wilson, Deputy Director of Political Strategy and outreach for the White House.

In the Friday meeting of the Women's Caucus, Joanne Sullivan was elected as one of three vice chairs under the chairmanship of returning chair, Lottie Shackleford. Congratulations, Joanne! NFDW is well represented on the DNC with these two leadership positions. Jen Psaki, Press Secretary to President Biden was the guest speaker at the Women's Caucus. This was a wonderful, energizing meeting for more than 100 participants.









A Historic Moment

We know that she will be elevated to sit on the Supreme Court. We all will be excited to call her *Justice* Ketanji Brown Jackson.

EASTERN REGION

Greetings from Connecticut

The Connecticut Federation of Democratic Women (CFDW) will host a special workshop in May to celebrate their 100-Year Anniversary. The Connecticut Federation is the oldest federation in the country, and was established in 1922, a year after the passage of the 19th amendment giving women the right to vote.

Fannie Dixon Welch, out first president, set the standard in 1922 when she founded the Connecticut Federation of Democratic Women's Clubs. Her involvement with the Suffragette Movement that allowed women to have the "right to vote" was pivotal in making women keenly aware of their responsibility of understanding the workings of government, getting involved in their own political parties, and running for public office to "take their place side by side with men." The keynote speaker will be Connecticut's Secretary of State, Denise Merrill, who will speak on voting rights.

SOUTHERN REGION

Greetings from Mississippi

This August, Gertrude Guy Bridgeforth will complete 100 years of family devotion, social activism and bible study in Mississippi and Tennessee. Even now, at the age of 99, Gertrude still registers people to vote, asks for signatures on the Mississippi Early Voting Initiative petition, passes out sample ballots for every election and educates Mississippians on her living history in DeSoto County.

Gertrude remembers the great women of color Like Fannie Lou Hamer and Ida B. Wells and their shared experiences such as fighting to vote, riding in the back of the bus and even walking because of a lack of transportation. Racism was used to justify why Gertrude was denied a public education as a child, had to use separate restrooms and drink from water fountains that were marked as colored, and even worse – she could not check a book out of the library because of her skin color.

Times were difficult for all who fought for justice in Mississippi which the Guy family did in Southaven.

Gertrude first organized voter registration meetings at the DeSoto Methodist Church with her father Frazier Guy Senior, which was the center of voter registration in DeSoto County at that time. The Guy family received 3 death threats because of their civil rights activities. In 1966, Gertrude supported the 220-mile, 19 day March against Fear with James Meredith from Memphis to Jackson MS and passed out food and water to those who marched, which resulted in 4,000 African Americans registering to vote in Mississippi.

In her 80's Gertrude was still participating in GOTV rallies and protests with on the square in Hernando. Gertrude was an invited guest to President Barack Obama's first State of the Union Address, and later we got to see her profile on Saturday Night Live who did a skit on Barack Obama's 1st State of the Union address.

It is with great pride that I present Gertrude Guy Bridgeforth who is a pioneer in DeSoto County registering and encouraging people to Vote.







Greetings from Florida

The Florida Federation began 2022 planning or participating in Martin Luther King Day community events around the state including breakfasts, rallies, food drives and parades. Statewide grassroots efforts led by or in consultation with the Grassroots committee included calls, letters and texting thousands of voters encouraging Vote by Mail sign up. The Legislative Committee tracked more than 1300 bills this session and called on members to make phone calls, write emails or text our state legislators advocating for or opposing various bills as they went through the legislative process. We had a difficult Legislative Session this year, and many activities were planned to oppose and educate Florida's constituents on the dangers of the 15-week Abortion Ban, Don't Say Gay Bill, Stop Woke Act. Members held sign waving events around the state, spoke out at various events and invited state legislators to speak on issues.

Our State Convention is April 28-May 1, 2022. All 13 Regions have assumed a role in the planning and execution of the event. Included in the weekend activities are a reception with Legislators and Members, Business Meetings, Speakers, a Gubernatorial Candidate Forum, 14 robust Workshop sessions and our Annual DWCF Awards Gala.

Bylaws Recommendations:

The proposed Bylaws amendments with the Bylaws Committee's recommendation go out with the April Call to Convention with the following guidelines:

- 1. State Presidents are asked to meet with/contact their clubs, as they desire, to get input, questions, and votes to be prepared to meet with the Region
- 2. Regional Directors set a meeting with their state Presidents (May); have any needed discussion, write questions and forward to Bylaws Chair, as needed. Questions then are addressed prior to Convention (Bylaws Chair can be invited to those meetings) (Note: a vote tally sheet will go to the Directors in a few days).
- 3. During Convention, limited time mandates that when the Regions meet, they get roll call votes by states and that they are prepared to cast those votes during Convention.
