



The 28th Amendment ERA

US Constitution

The 28th
Amendment
ERA



Section 1. Equality of rights under the law shall not be denied or abridged by the United States or by any State on account of sex.

Section 2. The Congress shall have the power to enforce, by appropriate legislation, the provisions of this article.

Section 3. This amendment shall take effect two years after the date of ratification.

Why ERA

Why ERA

It must be now. We must secure the ERA. There must be equality.

In a moment shocking the conscience of our nation in 2022, we suffered a revocation of constitutional protections, resulting in the overturning of rights to reproductive healthcare.

Moreover, we continue to experience:

- Disproportionate rates of poverty burdened by economic gaps in equal pay, retirement income and benefits/pensions which are magnified by race, occupation, and class.
- Workplace discrimination
- Epidemic rates of rape and violent assaults
- Lack of political parity

Every constitution enacted since WWII contains a sex equality clause, but the United States does not.

In fact, the <u>Global Gender Gap Report 2022</u>, which tracks progress on benchmarks on closing gender gaps to achieve gender parity, reveals that the United States is performing relatively poorly despite our reputation as a superpower and the greatest democracy in the world.

History Highlights

History 1920s – 1940s

The ongoing history of waiting and being denied constitutional equality is a long one bringing us to the 100-year mark of being denied.

July 21, 1923 – Alice Paul, leader of the National Woman's Party, introduced the ERA at the Seneca Falls Convention celebrating the 75th anniversary of the first woman's rights convention in 1848: "Men and women shall have equal rights throughout the United States and every place subject to its jurisdiction."

December 13, 1923 - Congressman Daniel Read Anthony, Jr. (Susan B. Anthony's nephew), introduced the first ERA bill, <u>H. J. Res. 75</u>, in the U. S. Congress.


1923-1972 – The ERA was introduced at every session of Congress until passage in 1972.

1940 – Republican Party included the ERA in their platform for the first time.

1943 – Alice Paul rewrote the ERA to reflect the wording in the 15th and 19th amendments in its final form: "Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex."

1944 – Democratic Party included the ERA in their platform for the first time.

History Highlights

History 1970s – 1990s

August 10, 1970 - Martha Wright Griffiths, U.S. House Representative, spearheaded the passage of the ERA in the House through a "discharge petition;" the Senate did not pass the ERA that year.

October, 1971 - Martha Wright Griffiths again called for the passage of the ERA in the U. S. House via a "discharge petition;" it passed 354 to 24.

March 22, 1972 – The ERA passed U.S. Senate (84 to 8) and was sent to states for ratification with a seven-year time limit (1979)

1977 – Thirty-five states had ratified the ERA; thirty-eight needed for ratification.

1978 – Congress passed a bill extending the ERA ratification deadline to June 30, 1982, ratification by thirty-eight states did not occur by this date.

1992 – The Madison Amendment on congressional pay raises was ratified 208 years after approved by Congress, setting the stage for legality of ratification of the ERA.



History Highlights

History 2017 – 2022

2017 – Nevada was the thirty-six state to ratify the ERA.

2018 – Illinois was the thirty-seventh state to ratify the ERA.

2020 – Virginia was the thirty-eighth state to ratify the ERA, meeting the requirement for publication in the U. S. Constitution.

January 6, 2020 – The National Archivist refused to publish/certify the ratifications without a court order based on an Office of Legal Counsel (OLC) 2020 opinion - Trump Administration.

January 30, 2020 – The last three ratifying states filed a lawsuit against the Archivist which is ongoing. However, Virginia withdraws from the case in 2022 following an election of a new Attorney General.

January 6, 2022 – The OLC issued a new 2022 opinion that the previous opinion in 2020 wasn't an obstacle to Congressional action on ratification - Biden Administration.

January 27, 2022 – President Joe Biden issued a statement "...calling on Congress to act immediately to pass a resolution recognizing ratification of the ERA."

January 28, 2022 – H.Res. 891 was introduced, expressing the sense of the US House that the ERA is valid. Bills dropping the time limit also continued to be active. None of the ERA bills passed.

January 2023 – House (HJ Res 25) and Senate (SJ Res 4) were introduced affirming the passage of the ERA, removing the time limit.



State

1. Federal Constitution Level

There are <u>12 states</u> that have not ratified the ERA to further affirm the 28th amendment to the US Constitution.

2. State Constitution Level

There are 18 states that have no ERA amending their state constitution.

There are 6 states that have limited gender equality provisions in their state constitution.

There are 4 states that have active state constitutional ERA ratification efforts underway.

There are 22 states with ERAs in their state constitution. Note NV recently moved into this category in 2022 with a remarkably comprehensive state ERA.

If you live in a state that has not ratified an ERA at the federal level, or a state that is not ratified or has limited gender equality provisions at the state level, and you are interested in advocating for an ERA, contact the ERA Legislative Subcommittee, NFDW. We will assist you in connecting with any existing advocate network in your state.



Action

State Law Audit Project

1. Review ERA Coalition's State Law Project. In anticipation of publication of the ERA in the U. S. Constitution, the State Law Audit Project was established to move gender equality forward, states are encouraged to look at state statutes and regulations for gender bias.

Most state legislatures have a drafting and research office, staffed by professionals to serve legislators in drafting new laws.

Please ask your state legislator to pose a question to their Legislative Research office about the use of gender terms in state law. A sample letter, and additional information is available upon request from the <u>ERA</u> Coalition.



Some state volunteer organizations are working with pro-bono lawyers to support the State Law Audit Project efforts. States such as Arizona, North Carolina, Virginia and Ohio are using this volunteer-led method. Arizona's final statutory review is available online.


Action

State ERA Affirming Resolutions

Work with your state legislatures in both ratified and unratified states proposing a resolution affirming the Equal Rights as the 28th Amendment. A sample resolution is available at ERA Coalition.

As of January, legislators in **Georgia** (<u>H8</u>), **Illinois** (<u>HJR1</u>) and **Minnesota** (<u>SF47/HF197</u>) introduced a resolution affirming the Equal Rights
Amendment. Last session, legislators in **Tennessee** (<u>HJR0757</u>), **New Jersey** (<u>SJR48</u>), **California** (<u>SJR12</u>), and **Ohio** (<u>HRC51</u>) did the same.

Sample Resolution

Centennial Affirmation of the Validity of the Equal Rights Amendment (ERA)

WHEREAS, 2023 marks the centennial of the introduction of the first ERA into Congress in 1923 and the continued denial of affirmation of an ERA to the United States (US) Constitution guaranteeing equal rights under the law without regard to sex; and

WHEREAS, women, who constitute over 50% of the population of the United States, play an essential and irreplaceable role in society, contributing to our economy and advancing our nation in both public and private realms; and

WHEREAS, women continue to confront workplace discrimination, wage inequities, health care inequities, higher rates of poverty, rape and domestic violence assaults, a lack of political parity, and other forms of sex-based discrimination that are particularly compounding issues for Black women, Latinas, Indigenous and Native American women, immigrants, LGBTQ+ women, single mothers, and women in the military services; and

WHEREAS, state and federal anti-discrimination laws are not uniform or comprehensive, and can be repealed, amended, or ineffectively applied by the courts; and

WHEREAS, the ERA is essential for correcting systemic sex discrimination since it would constitutionally guarantee that "equality of rights under the law shall not be denied or abridged by the United States or by any State on account of sex."; and

WHEREAS, the United States of America is the only industrialized country that does not explicitly recognize the equality of women in its constitution, and 94% of constitutions adopted since 1970 include a rule establishing the equality of women; and

WHEREAS, Article V of the U.S. Constitution sets out two requirements for amendments: approval by two-thirds of both chambers of Congress, and ratification by 3/4 (38) of the states, and the ERA achieved both requirements with Virginia's ratification on January 27, 2020; and

WHEREAS, ratifications cannot be undone, as evidenced by the inclusion of our Fourteenth, Fifteenth, and Nineteenth Amendments despite purported rescissions; and

WHEREAS, in January of 2023, congressional resolutions were introduced in the House (HJ Res 25) and Senate (SJ Res 4) by Representative Ayanna Pressley (D-MA) and Senator Ben Cardin (D-MD), respectively, affirming the validity of the ERA and removing the time limit; and

WHEREAS, although passage of the resolutions is not required, Congress can and should act to remove any ambiguity that there is no time limit on equality.

THEREFORE, BE IT RESOLVED,

that we support the passage of congressional bills affirming the validity of the ERA and removing an arbitrary time limit in the preamble; and the publication by the National Archivist of the ERA as the 28th Amendment to the U.S. Constitution.


